Letter from the Director

The Glavin Office of International Education's International Student and Scholar Services (ISSS) team is committed to providing culturally sensitive and comprehensive advisory services of the highest quality to Babson's international students and scholars and their families. We educate and advise on ever-changing U.S. immigration regulations and provide outreach and support when events may affect our international population. As we do so, we are mindful of each student's unique experiences and complex identity (including but not limited to their nationality, heritage, faith, gender, sexual orientation, and socio-economic status).

As a snapshot in time for the fall semester, the ISSS annual report illustrates Babson's international population but does not capture all of the students/scholars with whom we work in a given year. Statistics not captured in this report include students only enrolled in the spring or summer semesters, Executive Education, Babson Academy programs or part-time graduate programs.

While this report also does not capture the 307 U.S. dual citizens or 119 U.S. Permanent Residents currently enrolled, we recognize that they bring additional perspectives that further enrich our campus community.

We welcomed more students in Fall 2021 than ever before and close to 60 additional students entered the U.S. after starting their programs from abroad after the pandemic-related mobility issues of the academic year 2020-2021. Through cross-campus collaboration along with U.S. travel and visa issuance improvements, we are thrilled that almost all of our returning and incoming students were able to return to campus to resume in-person classes.

It continues to be a privilege to work with our diverse international population and with colleagues across campus who also strive to maintain Babson's commitment to creating a welcoming, affirming, and inclusive community for all students. I hope you find the report useful and welcome any comments or questions.

International Student & Scholar Services (ISSS)

The Glavin Office's ISSS team is one of the first to engage with admitted international students, months before they set foot on campus to assist them through the U.S. student visa process. Upon arrival and throughout their program ISSS provides support and guidance around immigration regulations, employment authorization, and adjusting to living in the U.S. ISSS staff also advise recent alumni authorized for U.S. work authorization for up to three years post-graduation.

Total international student enrollment for fall 2021 far exceeded fall 2020 levels and went up 7% from pre-pandemic fall 2019 numbers. In addition, Babson welcomed 4 graduate and 52 undergraduate international students who began their programs from outside the U.S. and finally arrived to campus this fall.



Global mobility increased in part due to U.S. travel restrictions determining that international students would be a national interest exemption along with the U.S. Department of State making significant strides to issue visas for the start of the semester.



191 new undergraduate international students and 282 new graduate international students started their programs in fall 2021.



Babson welcomed 9 new undergraduate students from Brazil, Egypt, India, Kenya, Liberia, Rwanda, & Ukraine as <u>Babson Global Scholars</u>, members of a need-based scholarship program launched in 2014.

BABSON IN CHINA

The Babson in China program ran for the third semester to provide academic continuity for our undergraduate students from the region. Eight students (4 incoming and 4 continuing) participated in the program Xi'an Jiatong-Liverpool University in Suzhou, China through a partnership with The Asia Institute.



22 international students (18 undergraduate and 4 graduate) from 14 partner institutions attended Babson on incoming exchange during the fall 2021 semester.




International Student Population







International Student Percentage





Visa Representation







Curricular Practical Training (CPT) - AY 20/21

CPT is temporary work authorization granted to F-1 international students to get practical training for a U.S. internship that is related to their degree as an "integral part of an established curriculum." Students are eligible for CPT authorization after completing two semesters in F-1 status.


Note: Due to the COVID-19 pandemic, CPT authorization statistics decreased in part due to reduced overall student enrollment, international students studying from outside the U.S., and/or available internship opportunities during the academic year 20-21.

OPTIONAL PRACTICAL TRAINING (OPT)

Optional Practical Training (OPT) is temporary employment authorization for F-1 international students related to their major area of study.

Post-Completion OPT is a period of OPT (typically 12 months) following a student's completion of their program. STEM OPT is a 24-month extension of OPT for students who meet eligibility criteria pertaining to their job, employer and a degree in certain Science, Technology, Engineering, or Math (STEM) fields.

Four Babson graduate programs with have STEM designation.
